# Deregulation

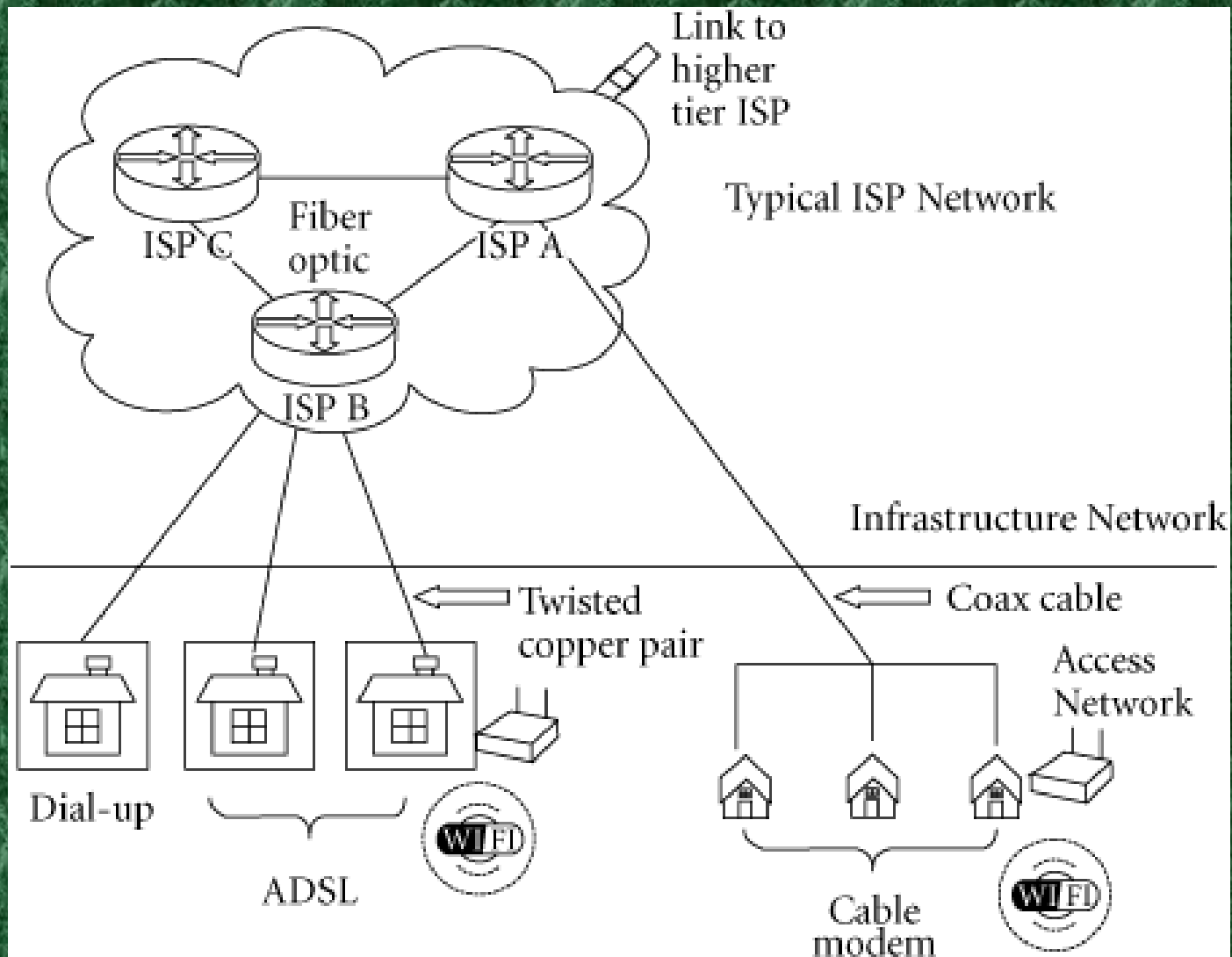


# Investment

- Worldwide Telecom revenues estimated at \$ 3.5 trillion in 2007, and is expected to grow 10% annually.
- \$225 Billion in investment in 2007.
- 24.4% increase in internet access revenue.
- 251.5 million 3G cellphone connections worldwide.
- \$1.3 trillion in wireless revenue projected in 2011.

# Four Principles

1. Consumers are entitled to access the lawful Internet content of their choice;
2. Consumers are entitled to run applications and services of their choice, subject to the needs of law enforcement;
3. Consumers are entitled to connect their choice of legal devices that do not harm the network;
4. Consumers are entitled to competition among network providers, application and service providers, and content providers.





# Child Internet Safety

- In the United States:
  - between 1 in 7 and 1 in 25 children have been solicited online.
  - 28% of online teens have created their own blog.
  - 27% maintain their own webpage.
  - 39% share their own artwork, photos, stories or videos online.
  - 41% of teens who use MySpace, Facebook, or other social networking sites send messages to their friends everyday through these sites — while only 22% of teens send messages via email everyday.
  - 42% of children have been bullied online, and 1 in 4 has had it happen more than once.

# Piracy

- Worldwide, for every two dollars' worth of software purchased legitimately, one dollar's worth was obtained illegally.
- \$48 Billion (USD) loss for software alone.
- For every song that is bought legally, in shops or online, around 20 songs are illegally downloaded

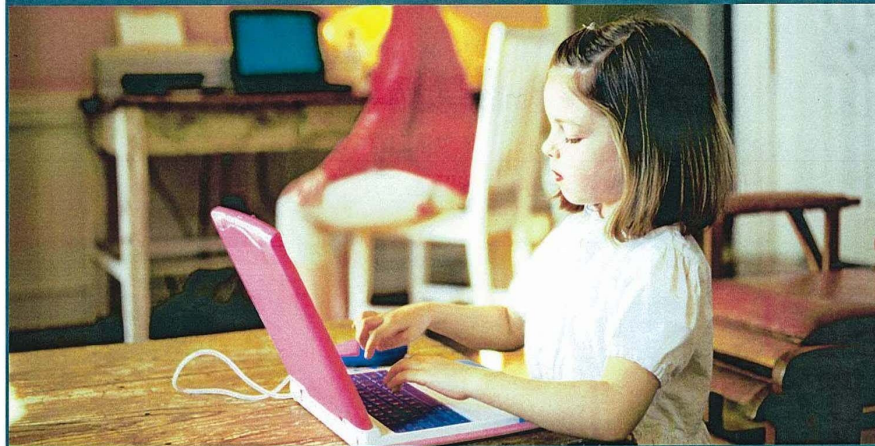
