MAIRIE DE PARIS CITY OF PARIS, THE DIGITAL CITY (PARIS VILLE NUMERIQUE)



Paris, one of the leading ICT cities in the world, disposes of a unique network in terms of coverage and the number of Internet providers offering high speed connections. Universal Internet service will be offered for free to the Parisians by 2008 - this also includes WiFi for a 100% coverage in the near future. Several hundreds of companies working in the ICT sector are located in Paris and its neighbouring departments. The ICT sector alone generated more than 300,000 jobs in the region. As regards the social dimension, the City of Paris benefits from an important network of associations deeply rooted in the life of the city's districts.
